Properties / Applications

Bayfol CR 1-4 000000 has advantages over standard polycarbonate films in terms of dynamic strength, dimensional stability and cold formability. Typical applications are automotive, keypads, membrane switches, hand held electronics, appliance, nameplates, touch panels and FIM - film insert molding decoration.

Bayfol CR 1-4 000000 is available in various standard thicknesses from 0.005 " to 0.015 " (125 microns to 375 microns). Other thicknesses are available on request. The surface combination of Bayfol CR 1-4 000000 is one side gloss and one side fine matte for printability. As with any product, use of Bayfol CR 1-4 000000 in a given application must be tested (including but not limited to field testing) in advance by the user to determine suitability.
